**First:** To pay Case Closed Bail Bonds, LLC herein referred to as C.C.B.B. or Company \$ \_\_\_\_\_ as non-refundable fee for the bail bond. The premium is fully earned upon the release of the principal. The fact that the defendant may have been improperly arrested, his/her bail reduced or case dismissed shall not obligate the return of said premium.

**Second:** To guarantee the payment of said bond to the above named bail bond company or named representative in the event of forfeiture by the above named principal. Acknowledge yourself as fully bound by all provisions of the above stated bail bond, and expressly agree to pay upon an executed final judgment of forfeiture, any amount owing, not to exceed the amount of forfeiture ordered thereunder. Collateral and/or valid card information may be required by Company to be applied for indemnification purposes contained herein. Case Closed Bail Bonds, LLC is authorized to levy upon said collateral, in the manner provided by law, and to apply the proceeds therefrom for reimbursement for forfeitures. This agreement is effective and binding upon the undersigned throughout all stages of the proceedings in the trial divisions of the General Court of Justice until the entry of judgment in district court from which no appeal is taken or until the entry of judgment in superior court.

**Third:** The obligations hereunder are joint and several. Company shall not be obliged to proceed against the Principal before having recourse against other obligated parties. The undersigned hereby expressly waives the benefits of law requiring C.C.B.B., the Surety or the bail agent to make claim upon, or to proceed or enforce its remedies against the Principal before making demand upon or proceeding and/or enforcing its remedies against any one of the other undersigned. The undersigned waives rights to privacy under federal and state law and authorizes C.C.B.B. or its appointees to use any current or future technology that may become available, in the manner provided by law, to locate and enforce the terms of this bond contract, without restriction or prior notification of any kind.
